Chapter One: SPECTRUM SCIENCE

As the USSA and USA move ahead, a new science will prove extremely helpful in nailing down the "Front-end Why's" behind each country's respective worldview visions. The mathematics-based Spectrum Science will inject the notions of how one's current political worldview is derived, how one's sexuality and inclinations are nature-driven, and how one's choices are ever-evolving weekly trade-offs for determining the likelihood of class outcomes for oneself and the class outcomes of their, if any, offspring. It will do so by providing new terms for categorizing, labeling, and measuring where adult humans fall in comparison to each other.

Spectrum Science is based on capturing the entire universe of possible combinations for an individual adult human. Spectrums on which one can self-identify where they fall at any given moment if they so choose. It then quickly explains away the modern-day distortions and limitations of existing "labels" terminology, leaving little to no room for doubt: None of this is random and at the same time is very explainable in terms of Equal Outcomes vs. Equal Opportunities.

In any fact-based argument, numerators and denominators always have mattered and are as of this writing, officially no longer avoidable. So do statistics, sample sizes, and reliable metrics matter. For example, if there are just a handful of independent human interactions during a calendar year that are considered negative in a Nation of 330 million people, that is not proof of systemic this or that. In fact, it is likely proof that it is not systemic at all. Considering how quickly and how much attention can be given to such negative interactions when they "fit the approved narrative," it is unlikely that any are *not* reported.

Further, when it comes to a group of 30 to 40 or so million adult humans residing in the current USA taking the same exact and often extreme position in lockstep on every political issue, conflict, and cause every time, and—no exaggeration—immediately, that is mathematically explainable as well. There must be at least one common denominator, and there is as the Mind Spectrum will explain. There is also a common denominator explaining one's activities and income-related choices in life via the Sexuality Spectrum. Further, the Class Spectrum will also reinvent the discussion on an adult human's class status at that exact point in their lifetime, as the common denominator is uncovered here as well.

Collectively, Spectrum Science will rise above the existing political, sexuality, and class status labels to nail down what is really going on in terms of Equal Outcomes vs. Equal Opportunities. However, clamoring for statistics for this or that fact claim, plus the qualifications and fields of study/expertise by those who state them, will leave some disappointed at first with *Last Call Manifesto*. But that disappointment can be quickly replaced by the guaranteed self-empowerment of connecting the dots with one's own eyes and ears. Spectrum Science will without a doubt set one's mind free on how the breakup of the current USA is the only way forward.

Mind Spectrum

Without exception, those same 30 to 40 or so million adult humans residing in the current USA literally and religiously see everything the same way politically. If there are 100 different economic and/or social political issues, they all grasp on to the same exact worldview position on every single one of them. People who have never met each other before instantaneously conclude the same exact political positions.

Simultaneously, this same group enjoins to not just criticize those who do not see eye-to-eye with them, but to delegitimize, punish, and/or hate them. Meanwhile, those that hold opposing viewpoints—whether on just one or two significant political issues or most with that same group—are continuously puzzled on how they hold so much animosity towards them, even as they time and again are accommodated and appeased. None of this is random.

A human's brain is part of the visible, tangible world of the body. A human's mind is part of the invisible, transcendent world of thoughts, feelings, emotions, attitude, beliefs, and imagination. The brain is the physical organ most associated with mind and consciousness, but the mind is not confined to the brain. The element, part, substance, or process that reasons, thinks, feels, wills, perceives, and judges.


It is recognized how the human brain's numerous functions fall into distinct halves – empathy on the right side and logic on the left side. Based on this universally accepted nomenclature, there are mathematically four possible empathy/logic combinations shaping an individual adult human's mindset: "all" empathy and little logic; balanced empathy and logic; little empathy and "all" logic; or little empathy and little logic.

For those who have a mindset characterized as having little empathy and "all" logic, the latter often transforms into illogical thinking overall. Just think sociopath or psychopath and how there is little to no conscience concern of

others. Contrarily, those who's mindset is characterized by "all" empathy and little logic, the "all empathy" transcends into almost non-stop "il-empathical" thinking. With little to no logic to balance one's empathy, there is no limit to how far one's mindset can ascend new heights of experiencing the feelings, thoughts, or attitudes of others not as fortunate as themselves.

Those who are characterized as having a mostly balanced empathy and logic mindset are comfortably empowered to individually think in a reasonable and rational way. Then the characteristic combination of little empathy and little logic traps one's mindset in the complete opposite direction, often producing individual thinking which is unreasonable and/or irrational. Meanwhile, those with "all" and "little" combinations in either direction will often display similar levels of unreasonableness and irrationality.

The above mindset characteristic combinations then lead to the four categories and labels that form the "Thought Process Foundation" of the Mind Spectrum as follows. The Mind Blind ("all" empathy and little logic) fall on the spectrum's left; the Mind Balanced (balanced empathy and logic) are found in the middle; the Mind Blasted (little empathy and "all" logic) fall on the spectrum's right; while the Mind Blown (little empathy and little logic) create a loose connection to the left and right ends of the spectrum. Visually, as depicted below, this forms a circular spectrum for categorizing, labeling, and measuring the adult human mind.



The Mind Spectrum Science begins with the universally accepted fact that infants start off with neither side of their brain developed and then they, in theory, eventually develop both halves throughout childhood until ages 18 and

higher. Further, the Mind Spectrum Science recognizes how the brain's empathy half is known to out develop the logic half through adolescence and into early adulthood. This can be the case no matter how educated or intelligent one is in their teens and early twenties.

The human has two primary brain halves for a reason no doubt, making Mind Balanced the predetermined natural state for an adult, just like the proportional development of both arms and both legs, which help a healthy adult human to balance physically vs. mentally. The Mind Balanced are therefore literally programmed to individually and at times critically think about every issue and cause presented to them. They think in terms of fact vs. opinion; objective vs. subjective; pro vs. con; while continuously factoring in the tradeoffs involved and any potential unintended consequences, which is all guided by their nurture-driven common sense.

Personally, the Mind Balanced strive to be the best they can be given what talents and skills they have to offer and/or have figured out how to develop. They choose to be mostly left alone and contribute to the local community in their own unique charitable ways. They believe in limited government which stands behind the basic societal safety and security-related roles, under a Law and Order-driven Capitalist society without "punitive-by-design" taxation levels on an individual's particular calendar year of financial success. They are also self-empowered to admit when they were wrong including not seeing the full picture. Even more important, it usually does not take long for one to resign their position upon being exposed and/or caught in the act, as warranted by their peers, especially for criminal activities.

However, when it comes to the political landscape both locally and nationally and how the two interact, a big downside is that the Mind Balanced tend to not pay attention until it becomes too late. Many Mind Balanced-led cities and towns in the USA historically espoused keeping taxes low on those that worked while maintaining work requirements for those on welfare. They also believed in preventing government employee incomes and benefits from crowding out expenditures on basic governmental services. But all of that can go away practically overnight when the Mind Balanced stay focused on their work and personal lives while the non-Mind Balanced political forces-to-be only focus on politics and how they can take over.

For the Mind Spectrum's left and right, the Mind Blind and Mind Blasted states rely mostly on some form of Group Think tied to common causes and even common hate against the others who do not think, act and/or look like them.

Suffice it to say, the Mind Blind and Mind Blasted rely on third-party conditions to persist. The Mind Blind count on focusing other's minds on multitudes of victimized groups and the villains who oppress them. It all comes down to getting those minds to concentrate solely on what is directly in front of them while ignoring context and the concept of trade-offs. This approach recognizes and relies on how contagious empathetic-driven thinking can be and calls for a robust analysis which will be forthcoming in this section.

As for the Mind Blasted, they typically but not always tie to a specific identity group *against* all others unlike them while mainly relying on the often insane or at least extreme-like mindset of others who *are* like them. With little to no empathy, they regularly neglect to put themselves in others' shoes while going about their daily lives. Blasted is informally used to express annoyance, which fits perfectly for those who behave in such a way. Blast also ties to "destructive" forces, which unfortunately can turn a Mind Blasted individual or group of them into mass murderers just like that as they become unhinged.

Much less complicated then fighting for Equal Outcomes or Equal Opportunities, the Mind Blasted endlessly continue to be drawn together by their one cause, typically tied to racial or religious purity, and by default, ideological purity. They generally look down on others with at best superficial intentions to convert them. To a lesser degree, the Mind Blasted also covers those who whip up conspiracy theories on just about anything with little to no credible evidence—to stir the pot of politics towards potential chaos. While Mind Blasted led entities exist in the USA, they generally are tiny fringes not in a position of any substantial political power or having any real voting sway circa the USA's 2020s, over others.

Then there are the Mind Blown who fall into the fourth and final category of the Mind Spectrum. Those who often espouse an "all on one's own" apolitical mindset and conditioning, given how the now teenager/young adult/adult still has not advanced either half of their brain. The abled-bodied humans whose brain is physically healthy but have declined to develop and maintain neither empathy nor logic into adulthood fall into this category. Their minds are considered blown out in every sense of the term.

The Mind Blown typically display their lack of both empathy and logic while accumulating multiple criminal offenses especially those that involve direct physical destruction to another human's and respective family member's lives, livelihoods, and/or private property. This can include shop lifting, graffiti,

window smashing, carjacking, rioting, burning, looting, assaulting, raping, shooting, and murdering.

The Mind Blown's lack of empathy for their victims is on full display while their lack of logic masks the reality on how it will never end well for them, especially given how easy it is to catch people in today's tech-surveilled world. This group also definitely includes those who spend their time on how to hack, scam, and/or frivolously sue others, but do not take too much time thinking out how they can get away with it. All while ignoring how many others will suffer. Identity thieves, swindlers, blackmailers, drug dealers, smugglers, and human traffickers fit in here as well.

In the same vein, sometimes literally, the Mind Blown label includes drug addicted individuals who renege on all self-responsibilities. They no longer see how many others they are hurting both mentally and monetarily as those in their life must deal with them, including family, friends, employers, and landlords. Addictions of any kind which then lead to homelessness put even more pressure on others on what can be done to correct the addict's life trajectory. Such rampant and consistent drug use takes the blown in the Mind Blown label to even lower probability levels of ever creating/recreating and then maintaining their personal self-reliance and/or self-well being.

In a similar manner to the Mind Blasted, the Mind Blown are not found in many if any positions of power in the USA, other than being used as pawns for chaos on behalf of the Mind Blind. Gangs, mobs, and other organizations which by name and charters alone insinuate violence as its choice of intimidation. While the Mind Blown hold no real direct power in the USA, they can certainly influence any given election. Especially when coerced with money, alcohol, and/or cigarettes into same day voter registration and voting.

One thing is for sure, the Mind Blown have not built much of anything in society but many if not most to date have broken plenty through the aforementioned criminal acts such as graffiti, window smashing, rioting, burning, and looting, etc. Their only moments of power over others throughout their lives-to-date is the threat and periodic execution of criminal acts against the innocent.

Given their all-encompassing goal of "fundamentally transforming" Capitalism to Socialism via Statism wherever they are and wherever they go, the Mind Blind have a make or break need to mentally control each new generation starting at birth. It is then necessary to continuously coerce them in adulthood to maintain their Woke-ness. Otherwise, there is always a chance that the

human mind will Walk-away at some point once logic is ignited to full capacity. The Mind Blind command a mental purity state or else, of mostly all empathy and little to no logic, which can be often achieved via some combination of brainwashing (revising history/downgrading math), bribing (free stuff/zero responsibilities) and/or bullying (belittle opinions/cancel culture).

As for the brainwashed Mind Blind, especially the past two generations, this has never been about the Science. The Mind Blind adults have brilliantly infiltrated the three key societal mechanisms that shape the thinking of the youthful for decades now: the education system; the entertainment system, and the media system, especially Social Media.

No doubt, empathy-only thinking is behind this of course, and here's how: empathy drives the desire in Mind Blind adult humans to "teach their values" for the better good through the education system; to "promote their values" for the better good through the entertainment system; and to "reinforce their values" for the better good via the latest media avenues. Simply put, empathyonly Group Think and associated Victim-Villain everywhere mentality draws the Mind Blind in while it simultaneously shuts down Mind Balanced thinking.

Hence there are now subsets of multiple generations that believe competition is lame and measuring efforts and results is wrong, all while acting up when they do not get their way or simply deciding to misbehave is a declared human right. It started with grade school participation trophies and morphed into no real academic grading or even merit system at all. All while making any form of bad classroom behavior—now including criminal assault—no longer an infraction worthy of much discipline. Lowering and even eliminating admission standards and graduation requirements—except for mandatory gender and race studies—is now the go to method to level the playing field at Mind Blind-led colleges and universities in the USA.

However, Progress towards an Equal Outcomes Utopian society does not stop. What generational Mind Blind-thinking heights have such calculated long-term measures taken the drive for Equal Outcomes Progress post-schooling? Just think major worldwide Corporate sponsorships and donations 2020 and explicit calls to "Defund the Police" in order to increase "Community Investments." Then throw in the ever expanding and financially thriving grievance industrial complex. That is how high.

To the Mind Blind, the Truth is based on one's Thoughts, especially the latest Truths the Mainstream Media is cultivating against the Mind Balanced day after day. One's Feelings at any given moment represent the Facts, hands down. One's Emotions on a certain topic or cause is all the Evidence that is necessary.

The Science is whatever they Say and often Shout while they Shut down opposing thoughts.

When in a "debate," the Mind Blind do not need to answer the question, and after someone continues to disagree with them, they are free to openly display their angst. This can take many forms, including repeating the same Mind Blind approved narrative for that topic over and over. They are at liberty to also focus in on the one fact that supports their position even after nine points saying otherwise were politely expressed. In any political topic debate, the Mind Blind can claim that they have been offended, even within the first minute. From there the Mind Blind-patented name calling can soon be unleashed.

For the Mind Blind, there is unarguably a difference between the Truth and any Facts, Evidence, or Science presented by the so-called Mind Balanced, who appear to only want to systemically suppress everyone they can at every turn. Bottom line, anything presented by anyone that is not 100% on board with the Mind Blind's latest political agenda is at best a personal opinion—but more likely just Mind Balanced talking points—and therefore can never be accepted as fact.

In the opposite direction, the Mind Blind's ever growing governmental policy goals are not only *never* wrong on their face, but they are also never rescindable, period. It would simply be inhumane otherwise to take away new freebies and spending on the poor and disadvantaged (the Victims) and just plain unfair to reduce the tax burden on those who must pay for it all (the Villains).

At this juncture in the Mind Spectrum Science presentation, it is important to distinguish how easily empathy unchecked by logic hurtles sympathy and compassion thinking in the adult human mind with a look at their definitions:

sympathy [sim-puh-thee] noun

the fact or power of sharing the feelings of another, especially in sorrow or trouble; fellow feeling, compassion, or commiseration.

compassion [kuhm-pash-uhn] noun

a feeling of deep sympathy and sorrow for another who is stricken by misfortune, accompanied by a strong desire to alleviate the suffering.

empathy [em-puh-thee] noun

the psychological identification with or vicarious experiencing of the feelings, thoughts, or attitudes of another.

As one can see with the following real life example, sympathy is a feeling experienced as one walks by the panhandler; compassion is a step higher where one is driven by concern to at least momentarily alleviate the perceived suffering, which can be in the form of giving money or food on the spot to that panhandler; however, empathy takes one's feelings and emotions a lot further by putting oneself in the shoes of that panhandler not just at the moment but possibly the next day and the day after that.

The Mind Blind's empathy-only thinking without the counterbalance of logic can become unsettling for one's day-to-day self-worth evaluation. This is what drives oneself to always seek out the latest Victims, and then to feel good about oneself, identifying the perceived systemic and oppressive injustices by the obviously responsible Villains.

It is also what drives the passion to create an Equal Outcomes society via Progressive Socialism. It is the ultimate Victim vs. Villain identification mindset in everything they see. Essentially and literally, they can only see what is directly in front of them. Even history is seen in only the context of today's victimhood values, which is quite remarkable, unless it is their own personal controversial historical ties to the past.

Further, empathetic-only thinking enables the Mind Blind—when it fits the currently approved narratives—to turn a "blind eye" towards the Mind Blown often violent and destructive activities. This is made possible by the Mind Blind's day-to-day self-worth evaluation which can only be satisfied by a neverending fight for economic, social, environmental, and racial justice.

The Mind Blind are clearly the strongest in terms of their convictions. Without logic getting in the way of their empathetic-driven mindset, there are no boundaries to their Progress potential. Superficial boundaries such as budgets, borders, and birth canals, to name a few. Concerns with appearing hypocritical; lacking self-awareness; missing the irony; passing the blame; or lacking any room for compromise with the Mind Balanced can never get in their way.

Double standards as a standard for lowering standards and cherry-picking facts while ignoring trade-offs; risks vs. rewards; and benefits vs. costs make the Mind Blind the ultimate SJWs. It is all about good intentions, with any unintended consequences-related casualties and collateral damage all worth the fight for Equal Outcomes.

Meanwhile, the Mind Balanced—with their balanced empathy/logic individual thinking—can and will typical keep giving in to the demands of the Mind Blind, especially how the latter can never settle for "Yes" as an answer.

Often, sheer exhaustion from the Mind Blind's never-ending fight for Equal Outcomes and their dizzying means to get there are enough to draw the Mind Balanced to shrug; say "Yes" one more time; and move on.

There is always more room for Progress towards guaranteed Equal Outcomes, so goal posts are continuously moved and the current score (i.e., how much the Mind Balanced have relented) is not even counted. It flips the preverbal phrase of "give an inch and they'll take a mile" to "get an inch and we'll take a mile."

The Mind Blind sport their "Full Intolerance Shields" underneath their loyal Group Think and Group Passion on every issue every time creating the ultimate all or nothing approach to never compromising. Their endless energy to gripe, whine, and complain about the next thing deemed Sexist, Racist, Homophobic, Islamophobic, etc. or just culturally inappropriate is possibly unprecedented and certainly unmatched in any other walk of life. When it comes to any given political issue, once a position is established or a policy implemented, settling for anything less or giving in to reversing that position will never be tolerated or accepted. Just think marginal income tax rates of 90-plus percent in the 1940's/1950's and how badly the Mind Blind clamor for those days to return.

Further, the uninhibited use of projection by the Mind Blind can befuddle the Mind Balanced out of getting anything done, while providing cover for any "by any means necessary" maneuvering in the fight for Equal Outcomes. It is the Mind Blind's number one and most powerful weapon. When one is on the "right side of history" any behind the scenes wrongdoing—even for self-serving pleasure and enrichment—should not matter nor ever get in the way. What the Mind Blind projection powers do do however, is envision and empower one on how the opposition could be made to appear guilty of the same exact things (foreign country collusion, voter counting fraud, not-for-profit foundation money laundering, etc.) even if there is not one smidgen of evidence or proof.

A not-too-distant number two weapon employed by the Mind Blind are the words and terms they patently hijack and use in unison which are code whistles for income redistribution and/or Equal Outcomes. "Diversification"; "Inclusivity"; "Vulnerable"; "Disproportionate"; "Marginalized"; "Democracy"; "Disenfranchised"; and "Systemic" to name just a few. "Affordable" is one of the Mind Blind's most powerful words, especially when used in front of "Health Care" and "Housing." Most brilliant perhaps is the upgrading of terms once some lose their firepower and bite. A recent example is the step up for all out "Equity" in place of just "Equality" matched up with calls for "Unity," which basically translates into 100 percent our way on wealth redistribution or else.

Even more powerful for the Mind Blind's self-deemed noble Equal Outcomes mission is how they can declare unconditional Human Rights out of thin air (as in unlimited free Heath Care, responsibility-free Housing, Internet access for all, etc.) which in turn reduce the natural rights of others in one way or another but bring everyone closer to equal. Similarly, blanket statements of entire identity groups being this or that can simultaneously silence them while lassoing their ability to take a stand and fight back.

Then there is the tried and tested crisis-related maneuvering. By now most know that when one is fighting for Equal Outcomes and looking for even more income redistribution opportunities, one should hope for and then never let a good crisis go to waste. If none are on the horizon, the alternative that can work just as well is simply creating a crisis by manipulating numbers and/or the facts and circumstances of, say, a primary government function like the post office. Just state that there is not enough funding to get the job done even though it is not close to being the case. Then of course perceived solvable but 100% unsolvable crises are naturally the best kind especially on a global level (think climate and/or viral pandemic), given how hoaxing using tons of inaccurate information is perfectly honorable when it is for a "right side of history" cause.

The Mind Blind's ultimate secret weapon though is defending their Equal Outcomes agenda without spelling out how much it will cost the Mind Balanced taxpayers. Just how much their currently achieved monthly "after taxes" net income will drop even further than it already does once the Mind Blind's "Free Stuff Fair Share" (FS-squared) mantra finally takes hold. Upon the Mind Balanced speaking up, the Mind Blind will say that the USA is already Socialist in so many ways, so one has nothing to worry about. In other words, please stop the fear mongering as your only argument against the full potential of a Progressive Socialist society finally done right. Everything can go Socialist they say which aligns perfectly with the Mind Blind's "all or nothing" mindset.

A few more concepts for now to absorb. An override to any of the four Mind Spectrum states, which can easily be thought of as "Mind Brands," is the notion of being "power corrupted" or "PC'ed". Once power corruption sets in, practically anything goes towards obtaining more money and power and indefinitely maintaining and expanding that money and power position at the perils of others at any cost. They will say anything and stop at nothing. This can happen with people who fall under any of the four Mind Brands.

A PC'ed Mind Balanced adult human can easily give the appearance that they have shifted left or right on the Mind Spectrum, sometimes practically overnight. This is especially true for a life-long Mind Balanced political leader where suddenly they end up getting behind every single one of the latest Mind Blind causes and policy solutions. While it could be that said leader has simply succumbed to how contagious empathetic thinking can be, upon closer examination, it is explainable by the urge to hold on to or even create more power for themselves. It could also be a smoke and mirrors way of preventing the loss of power or even jail time due to the opposing party taking/maintaining control and subsequently exposing one's major misdeeds. Either way, the PC'ed Mind Balanced who cater and cave to the Mind Blind are typically thereafter "Balanced in Name Only" (BINOs).

Then there is how modern-day battle lines drawn are no longer about physical territory, other than safe spaces and a few scattered autonomous zones. The battle lines instead mainly tie to social constructs currently fought for and led by mocking each other for the way one thinks, leading to a huge difference in a respective Mind Brand's mocking targets and justifications.

The Mind Blind higher profile spokespeople relish in uniformly mocking the Mind Balanced for their individual thinking platforms. On the other hand, the Mind Balanced have no choice but to endlessly mock what has become practically daily coordinated Mind Blind signature Group Think attacks on practically every politically partisan issue to ever exist. The Mind Blasted know that their conspiracy theory-oriented Group Think is more often than not mock-able all while weaponizing the mocking of any or all other Mind Brands as well. As for the Mind Blown, they could care less about being mocked or wasting their time mocking others when there are plenty of "no longer punishable" criminal activities to expand, enhance, and/or explore.

The concept of lying amongst the Mind Brand categories must also then be considered, including making a false statement in response to a direct question, not voluntarily pointing something out as false, or worse, actively concealing it. In whichever form, the Mind Balanced know at that moment they are about to lie but can and will lie anyway. Then there are the Mind Blasted who just do not care if they must lie. The Mind Blown, on the other hand, have no choice but to constantly lie to cover up their intentional criminal and/or drug addicted misdeeds. This leaves the Mind Blind who, because of their Equal Outcomes aspirations, cannot even see that they are lying.

Outright lying is not to be confused with exaggerating (and even embellishing) or downplaying what will or did take place, something most political leaders are guilty of at some point. This is opposed to one of the most consistent forms of lying patented by the Mind Blind—the use of erroneous analogies to support their artful Fake News and unrepentant False Narratives.

The phrases "Apples to Apples" and "Apples to Oranges" have historically been invoked in analogy-like points that are conveyed in regular conversations. A badly needed third phrase, "Apples to Asses" (as in Donkeys) will now cover the over-the-top analogies being invoked in 2020 and beyond, including the comparison of recent political leaders and governance styles to those from the human race's wicked past. Referencing Jim Crow laws in conversations about in person voting and ID requirements in a year when IDs are necessary for inperson COVID-19 vaccination is beyond the pale in terms of such Apples to Assess analogies floating around out there.

Lastly, it will now be recognized how anyone who does not acknowledge the Mind Spectrum's four Mind Brands and where they vs. others fall on it, are guilty of practicing *Brand-ism*. Anyone who willfully only believes that they are automatically on the "right side of history" on every single economic and social political issue, are nothing short of *Brand-ists*.

Sexuality Spectrum

A big question about human sexuality is whether it is nature or nurture driven. As one will see in short order it is driven by nature. Once this is officially acknowledged, most claims of Gender Pay Gap discrimination in the USA can be explained away, especially the "On average, women in America are paid only 82 cents for every dollar paid to men." A claim that has not numerically budged much for the past decade (or longer). The same goes for those "glass ceilings" still to this day (?) holding women back from the top-level positions in the USA private and public sectors.

While such claims were indisputably true in most of the 20th century, many steps were taken in the USA to set the stage for emboldening gender equality in all educational and employment settings. Title IX; governmental employment-related non-discrimination laws, rules and regulations; and numerous large employer Human Resources-supported initiatives have all contributed to this noble and overdue initiative.

So much so, that the latest generational cohorts of youthful women have now had what prior generational cohorts did not—a leveled playing field and then some since birth—with their youthful men cohort counterparts in education and employment opportunities, especially in government. The incredibly successful results are there for all to see with one's own eyes and ears. The 2020 political chaos-related purview of so many women leaders in high level governmental positions—Governors, Mayors, Congressional, Bureaucratic, Police Chiefs, Captains, and Sergeants, etc.—is indisputable proof.

The historical and still current thinking of measuring *all* women against *all* men has been hiding the "Front-end Why's" behind the lingering misconceptions on alleged gender discrimination. This too is all explainable and reconcilable. It is not nurture-related, it is nature-related. Further blurring the truth are the standard sexuality categorizations tying to whether one has opposite-sex sex vs. same-sex sex vs. switching between both. That is, the old-school labels heterosexual, lesbian, gay (i.e., homosexual), and bisexual.

What if instead the categorizing and labeling was rearranged based on which aroused genitalia one prefers to have sex with? In doing so one can quickly realize that those who have sex with only aroused penises vs. those who have sex with only aroused vaginas have a lot more in common then otherwise formally recognized and acknowledged.

The underlying premise of the Sexuality Spectrum is that one's preference for sex between the two types of human aroused genitalia is tied to their female/male hormonal mix at birth, and not how their own genitalia matches up to their sexual partners'. This nature-driven thinking inarguably leads to three distinct groups.

Group 1 consists of those who are born with mostly female hormones, i.e., heterosexual women, gay men, and transgender women. Group 2 captures those who have a sexuality choice on which aroused genitalia they desire to have sex with at any given moment, i.e., bisexual women and bisexual men, driven by having a female/male hormonally mix split somewhere in the middle. Group 3 then includes those born with mostly male hormones, i.e., lesbian women, heterosexual men, and transgender men.

It is well established that most if not all humans are born with at least some amount of both female and male hormones, even if only a sliver of one or the other. With that premise accepted, the following linear thinking will help. Group 1's hormonal mix ranges somewhere between 99% to 75% female/1% to 25% male. Group 2 then falls somewhere in the middle with a hormonal mix range of 75% to 25% female/25% to 75% male. Group 3's hormonal mix range is then the opposite of Group 1's, i.e., between 25% to 1% female/75% to 99% male. The following Sexuality Spectrum Groupings Table provides a summary:

These specific groupings then help shape the foundation for the Sexuality Spectrum. Group 1, humans who only have consensual sex with aroused penises, are placed on the left. Group 3, humans who only have consensual sex with aroused vaginas, are placed on the right. Then Group 2, humans who can enjoy consensual sex with either type of aroused genitalia at any given moment, fall in the Sexuality Spectrum's middle. The humans who either completely abstain altogether or become permanently sexually inactive then represent the spectrum's circular portion which loosely connects its left and right ends.

The formulation of the upcoming Sexuality Spectrum mimics the formulation of the Mind Spectrum. That is, how there are only two types of aroused genitalia to have sex with vs. two halves of the brain to think with. For the latter, the distinct characteristic combinations underlying the Mind Spectrum's Thought Process Foundation are either "all" empathy and little logic; balanced empathy and logic; little empathy and "all" logic; or little empathy or logic.

For the former, the technically chromosome-based characteristics discussed so far helps create the Sexuality Spectrum's "Sex Partner Foundation." That is, humans who have: just aroused penis sex making them an XY-sexual; either aroused genitalia sex making them an X-plus-sexual; just aroused vagina sex making them an XX-sexual; or no aroused genitalia sex at all, making them an N/A-sexual, as in *not available* for having sex.

As a strict reminder, these new terms are designed to fill the gap in categorizing and then labeling adult humans based on which aroused genitalia they prefer to have sex with, regardless of what they identify as. Even better, the newly defined categories and upcoming labels necessarily respect any modern-day concerns about pronoun usage by not using any.

Setting up for getting to the "Front-end Why's" for gender employment and annual income differences, the Sexuality Spectrum Science then applies the labels of "Chasee" towards the left, "Chasesque" in the middle, and "Chasor"

towards the right. The Chasee prefers to be chased by a Chasor leading up to the first consensual sexual encounter; the Chasor prefers and often has no choice but to chase the Chasee leading up to the first consensual sexual encounter; while the Chasesque can be comfortable in either role. The label "Chaseless" is then used for those who do not or no longer have sex. This leads to the completed Sexuality Spectrum as depicted below:

Early in the presentation of the Sexuality Spectrum, it must be recognized how in most first consensual sexual encounters, there is typically one human playing the Chasee role and one playing the Chasor role, in order for that first consensual sex act to actually take place. This turning point moment between two consenting adult humans can happen months or even years after they first met. It can also happen within the same night that they meet. From there, no one can be sure if it ends up being just a one-night stand, or if they both like each other, simply a first-night stand leading to many more consensual sex acts ahead.

Whether it is many years or just a few hours, the lead up to two humans' first sex together consistently involves several elements. The Chasee sexually attracts the Chasor typically through their beauty, body, and *sexy* fashion. Given how much in Chasee competition the hook-up and dating world market bears, often times a Chasor's assumed focus can quickly zero in on the equivalently sexy Chasee's personality and desire to create and share some Company Time fun.

At the same time, the Chasor must own the means to bring the Chasee to their attention vs. the competing Chasors. This is the case given how many choices and how much accessibility to those choices a Chasee has in modern day times and dating apps. The means is typically through some combination of whatever charm, money, or power at the moment the Chasor can muster up, while the level of their own attractive physical look never hurts. No matter, the Chasee holds the "buyer" position over the Chasor's collective product with the final say.

There could also be mutual levels of chasing of course, but those encounters often can involve heavy alcohol consumption and/or more than two adult humans participating simultaneously. This holds true for same aroused genitalia sex just as much as opposite aroused genitalia sex. Such individuals could find themselves playing the Chasor in some matchups, while playing the Chasee in others, in terms of the first consensual sexual encounter.

A notable exception to the above is how Chasees are known to temporarily play the Chasor role when an otherwise Chasor is famous and/or has a lot of money and/or power, especially when the traditional Chasee is intoxicated. They then typically revert to their Chasee role in any longer-term sexual partnership that might be formed after that first encounter or two. The rule of thumb however is that the adult human with the highest percent of female hormones in a potential first-time sex partner pairing will likely play the Chasee role 8 out of 10 first consensual sexual encounters.

The Sexuality Spectrum Science next proceeds to make it so much easier to "connect the dots" and scientifically acknowledge how lesbian women, heterosexual men, and transgender men—all of whom fancy consensual sex with an aroused vagina—have so much in common with each other as primary Chasors. The "connecting the dots" exercise then gets even easier with grouping together the primary Chasees, i.e., heterosexual women, gay men, and transgender women, given how their commonalities are ever more visually prominent in public.

Early on in their teens and young adult years, the majority of primary Chasors share a common desire to play sports, especially team and physical contact sports such as basketball and soccer. Their male hormones give them a keener edge on competing and wanting to win at any costs. They also bring the same competitive edge to their career aspirations once in corporate positions, where the "C-suite" or Partnership level is the longer-term and ultimate goal.

Physically, primary Chasors are typically flat chested, while many opt to wear their hair short, although there are plenty of exceptions to these characteristics. They generally cover-up their torso body parts while in public unless tanning or on a sports field. They consistently pay for first dates almost every time, and even on their birthday. This no doubt is explained by how

primary Chasor lesbian women, heterosexual men, and transgender men carry a super-majority of male hormones vs. female hormones since birth.

The commonalities between primary Chasee heterosexual women, pure bottoms-only gay men, and transgender women are far more pronounced and ascertainable, especially where they overlap with their personal appearance efforts and concerns in terms of looking at themselves, fashion choices, dance moves, and of course taking selfies. With the latter, cameo photos and videos are taken regularly when out having fun and are often immediately uploaded and posted via Social Media for all to see. Although not immediately observable, there are also the behind-the-scenes selfies taken while scantily clad or even naked in private or with a few fellow Chasees. Images which then remain saved in one's smartphone to share or at least show trusted others when the moment is right.

As for looking at themselves, one can often witness how primary Chasees will check out their own profile and even buttocks while walking past a mirror or reflective window. Meanwhile, public observations which are just as interesting is the subconscious buttocks sway in their walk, which is especially common with primary Chasee heterosexual women (along with Chasesque bisexual women) who are experiencing their period. Of course, displaying one's entire buttocks cheek flesh via a thong is also a major overlap for sunning, swimming, and just having fun.

Another fashion-related common characteristic is how quick primary Chasees are to accentuate their body parts including one's chest and/or buttocks in form fitting, see-through sheer or lace, and even flesh flaunting styles. Such warm-weather choices include low-cut tops and/or short shorts, possibly with an inch or more of midriff exposed. All of which can draw extra attention from the surrounding Chasors, even before the need arises to reach up, bend over, or walk up a flight of stairs. Another popular phenomenon is the display of one's feet and especially toes in open toe footwear, even when it is cold outside.

Meanwhile, those same Chasees who experience a monthly menstrual cycle are known to dress even sexier when ovulating, wherein push-up bras or simply braless looks coupled with thigh-high skirts and 4- or 5-inch-high heels often can come into play. Another way to think about it is a female-hormone-driven adult human's sexuality subconsciousness can often appear to not have an off switch.

Before moving on to dance moves and other primary Chasee commonalities, it does not hurt to point out one prominent fashion-related connection moment between primary Chasee and primary Chasor women. That is, "Go Topless Day,"

an annual event held in the USA to support the right of women to go topless in public on gender-equality grounds. Topless freedom laws are celebrated while protests are held in states where topless women are prohibited. Basically, women throughout the Sexuality Spectrum go topless in public for a day, just like all men can.

However, the Sexuality Spectrum Science suggests that there is a stark difference in why primary Chasee heterosexual women and primary Chasor lesbian women join this cause. The former is subconsciously fighting for the right to publicly titillate others with their breasts. The latter are consciously fighting for the right to non-sexually go topless in the same manner as their fellow primary Chasor heterosexual men.

Getting back to the primary Chasee physical commonalities, there are the attention-grabbing dance moves which often end up with a focus on shaking one's buttocks, especially in a grind from behind dance move with their penisendowed dance partners. That is if not already dancing on the bar itself where many primary (or just secondary) Chasor observers can meet the primary Chasee "face to buttocks." Spontaneous lap dance moves, despite not being at a strip club, can materialize as the music beat takes control. In contrast—unless really intoxicated—at most primary Chasors will bop to the latest upbeat DJ song.

The primary Chasees also overlap in who gets consistently subsidized on their food, beverage, entertainment, and travel (F-BET) expenses when spending "Company Time" in public with one's non-cohabitating primary Chasor sexual partners or just friends. Not to mention other such "Indirect Pay" financial subsidies earned via gifts (jewelry/flowers), freebies (waived cover charges/free drinks), and favors (paying one's rent/handyman jobs).

When a primary Chasee claims that they cannot afford, say \$25 per fancy cocktail at a high-end bar, or their own birth control pills, one must take a big step back within the Sexuality Spectrum Science. Is it truly the case, or is it that the primary Chasee simply prefers to have others pay for that drink and/or birth control while spending their own hard-earned money on more personally tangible items such as new outfits for themselves or on their weekly manicure/pedicure visits?

Even more interesting perhaps, is how the primary and/or secondary Chasee will view a first sexual encounter as something they "give up" and that the respective primary Chasor "has to earn." Not a very Equal Outcomesoriented phenomenon between two adult humans when one thinks about it

from a modern-day Equal Outcomes perspective. Certainly, Sex Lives Matter (SLM), especially in a human's earlier adult life decades. Complexing the game further is when a Chasee group of friends is out and about brandishing their "No Intentions Badges." Yet all it takes is that one group of full intentions primary Chasors to come along with the right look, smell, money, and/or power, and anything goes consensual sexual encounter-wise from there.

Women now live at a time where they no longer need men for food, shelter, or security, especially in the USA circa 2020 where they can earn as much or more. Yet they still get subsidized. This is simply because female hormones still drive the sexuality of the Chasee women wherein their own "hormonal high" is best achieved when being chased by a new suitor leading up to a potential first time consensual sexual encounter. Now imagine how much those F-BET subsidies can add up during just one calendar year while playing the field, all while said subsidies continue unchallenged as legally non-reportable and thus non-taxable income to this day.

Beyond this type of aptly dubbed "Indirect Pay" for sex phenomenon, the "Direct Pay" for sex market is overwhelmingly a one-way street. Chasee heterosexual/bisexual women and gay men are consistently the ones paid directly for sex in cash or by credit card, by their respective Chasor sexual partner customers via prostitution, strip clubs, and/or happy ending massages. Undoubtedly, effeminate Chasees as "bottoms" are in high demand. Two possible exceptions to this are when Chasees go for their own full body massage wearing nothing or only a thong under an unsecured single towel, along with the occasional "girls-only" events which involve strippers with penises. Unfortunately, no matter who is paying and whether indirectly or directly, none of it to this day and volume is tax deductible as a self-well-being expense.

A #MeToo prevention moment of thought. If one is only planning to contribute their consensual Company Time with someone, the safest bet is to pay one's way or at least pay a proportional share based on individual incomes. Letting a primary Chasor consensually pay for everything while personally reaping the savings and benefits from it—without any intentions of having sex—maybe one should just not go there from the beginning. Primary Chasors with either genitalia can misread signals to thinking that they have a shot for at least one consensual first sex act, when in fact they do not.

Chasee *Sex Presentations* (the enhancement and display of their breasts/chests and buttocks) during acceptance of Chasor *Spend Presentations* (use of charm, money, and whatever power they hold in the moment) creates a perfect formula for misunderstandings of intentions. It is best to figuratively

cut the Company Time sharing off before it is too late and the Chasor in question ends up inappropriately making a move.

As for primary Chasors—who by definition have mostly male hormones and the associated masculinity—they can get awkward if not "stupid" rather quickly with sexual undertones, completely independent of the Chasee's actions or intentions. When a Chasee of their liking crosses their path, the urge to meet them and possibly have sex with them can become overreaching. They are known to within minutes "interview" the Chasee on everything possible about who they are (i.e., where are you from; where do you live; which high school did you go to; etc.) and at the same time, are prone to brag about themselves. One could almost wonder that the blood needed for their own genitalia arousal immediately starts shifting from their own brain functionality when they see an above average "hot" Chasee within striking distance.

Each of the sexuality-related commonalities between Chasee heterosexual women and gay men/transgender women as well as the differences between Chasee heterosexual/bisexual women and primary Chasor lesbian women pointed out so far in this section are crucial to understanding the Equal Opportunities and annual income differences between Group 1 and Group 3. It will now all add up with the Sexuality Spectrum Science in play. When it comes to income generating choices, so much can be explained, especially the "women in America are paid only 82 cents for every dollar paid to men." In fact, the "all" women vs. "all" men comparison is possibly the longest running Apples to Asses study ever.

Much of the claimed 18 cents difference is easily explainable by bringing in an Apples-to-Apples comparison, and once that is done, the gap narrows to more like 4 cents, i.e., 96 cents on the dollar. That is, factor in current age, education, and experience, plus differences in how many hours worked initially and ongoing, training needed, travel requirements, risk taking, physical and especially outdoor labor demands, and 14 of the 18 cents gap closes just like that. Now for the explanation on the remaining gap of 4 cents.

The number one answer is Vanity. But before diving in, it pays to look at the other and still to this day unspoken side of the gender pay gap disparity debate. What are the annual differences in what women are self-consuming versus men in general and especially in terms of vanity-related purchases for themselves? First, consider the differences in the number of monthly beauty salon and spa visits by heterosexual women vs. heterosexual men. Then consider how much

money on make-up, clothing, and especially shoes that adult women are spending on just themselves.

The black and white proof of how lopsided things have become on the personal consumption end of the unnecessarily prolonged gender wars is in the square footage dedicated to women products vs. men products at every mall and department store in the USA. It is at least 4 or 5 to 1 and easily can be more like 8 to 1 in some "co-ed product selling" places. This would not be sustainable if women are financially discriminated against still to this day in the USA.

The latest generation of adult women residing in the USA are exceeding in education and employment over adult men. They are earning more than men in many cases. They are affording their first homes on their own by age 35 or even younger. All while they still spend so much time on shopping and grooming themselves. Imagine what the gender-specific "pay gap" comparison would be if they shifted some of their individual weekly Vanity Time for personal shopping, deciding what to wear, polishing their nails, and doing their hair, towards earning more income.

Well one does not have to look far since the latest round of gender pay gap studies shows it to some degree. They now separate lesbian women into their own category, and the results are that they are paid more than heterosexual women. The studies claim that this difference is attributed primarily to differences in family structure. That lesbian women are more likely than heterosexual women to avoid the "motherhood penalty." In an age when motherhood is being pushed off by all women more than ever and child daycare services are abundant and more affordable, this claim is suspect. Yet, no mention of any other lifestyle variable differences such as Vanity Time.

To that point, the latest Pay Gap studies also show how Chasee gay men and transgender women are earning less than Chasor men. Pure bottoms gay men—who are said to outnumber tops-only gay men close to 9 to 1—hold their own collective set of Vanity Time demands. They are probably closer to heterosexual women weekly vanity hours at least in terms of shopping for oneself and deciding what to wear. Common sense then says that transgender women would command even more vanity hours per week than both heterosexual women *and* pure bottoms gay men given their extra gender identity-oriented needs.

Now for some more number breakdowns to help determine if women to this day are really being explicitly discriminated against and/or held back from breaking those glass ceilings. The following Sexuality Spectrum Headcounts

Table takes a stab at how 100 sexually active youthful adult humans in the USA's general population fall into the previously defined Groups 1, 2, and 3, split 50-50 between those with vaginas vs. penises at birth:

Starting with the Group 1 population which consists of 35 heterosexual women and 5 gay men/transgender women, there is little argument that their super majority female hormones lead them into fields which call for an extraordinary about of patience and compassion. These mostly primary Chasees tend to dominate the elementary school teacher, nursing, and caregiving industries in the USA to name a few. If there were an exact employee count taken across a wide number of elementary schools, hospitals, and nursing homes, the likely ratio of XX women to XY men would be close to Group 1's 35 to 5 headcount *Reality Ratio* of 7 to 1. This is a far cry from the 1 to 1 headcount ratio of vaginas vs. penises at birth found in the general youthful adult population.

Then there is the creative side of what a super-majority female hormones adult human can bring to the table, which is especially drawing primary Chasees towards the fashion, salon, and spa industries at practically every level. Here also one would find Group 1's Reality Ratio of 7 to 1 heterosexual women to gay/transgender men in terms of designers, hairstylists, and overall beauty technicians.

After reviewing the commonalities in primary Chasee employment, analyzing women-only employment environments such as the WNBA and Olympics women soccer will shed even more light on the realities of gender employment sexuality drivers. According to the general population Sexuality Spectrum Headcounts Table for youthful adult humans with a vagina at birth, a *non-discriminatory* mix of adult women's team members should be the ratio of 7 to 2 to 1 (i.e., 35 heterosexual women to 10 bisexual women to 5 lesbian women). But the *Reality Ratio* is basically flipped the other way and is more like 8 to 1 to 1 (i.e., 40 lesbian women to 5 bisexual women to 5 heterosexual

women). However, it is all explainable when the competitive nature of the Chasor lesbian women's super-majority male hormones is factored in.

Focusing in on lesbian women-dominated professional sports, the next step is to compare their annual salaries to those earned by heterosexual-dominated men-only professional sports. This will be short. Almost all adult men-only professional sports—especially those sports where physical contact regularly occurs—have fan bases which span the Sexuality Spectrum. Most Chasor fans can find themselves engaged by the masculine-fueled competitiveness while many Chasee fans if anything are drawn to that masculinity from a sexual attraction perspective. Women-only sports not so much. Men-only sports therefore bring in way more revenue than women-only sports given the huge differences in followers. Under an Equal Opportunities Capitalist society, men sports entertainers therefore get paid proportionally more than women sports entertainers accordingly. Done.

Even more unspoken truth can be uncovered via the Sexuality Spectrum Science by looking closer at the very physically demanding and/or high-risk occupations which any gender has access to in the USA's 2020s decade. To this day, heterosexual women and gay men are nowhere to be found in any significant numbers earning income in construction, sanitation, plumbing, landscaping, trucking, etc.

If the job at hand regularly involves getting grimed up, sweaty, smelly, physically exhausted, and takes on a much higher than average risk of injury or even death, it does not matter how much it pays. Even before factoring the demand for shifts that start at sunrise or run overnight while mostly outdoors. It also does not matter how much in "infrastructure" spending is legislated. Heterosexual women, gay men, and transgender women will never migrate in any significant numbers into these occupations, end of story.

The same goes for primary Chasors and the higher-end financial risk industries such as institutional investment banking. The historical combination of day-to-day risk taking, selling, buying, and schmoozing with clients after work when one knows that they have to be at it all over again at 7 AM the next day is definitely not drawing in many primary child-free Chasees to the field. Interestingly, this phenomenon does not appear to inhibit the primary or secondary Chasee from meeting and then potentially dating the primary Chasor bankers. Well at least the ones who excel in making crazy money while expanding their lavish personal lifestyles.

Although not a profession for most, the concept of putting one's own hardearned money at risk at the Casino or via sports or horse race betting are also primary Chasor commonalities. Meanwhile, while primary Chasees are much less inclined to gamble with their own money, they are the first to accept money offered to gamble from a friendly primary Chasor or group of them. A primary Chasor group that is highly likely to be on the prowl for a Chasee (or two) during their weekend stay at the Casino.

A literally glaring risk-taking employment-related example is how firefighter companies in the USA consistently have no less than a 9 to 1 men to women firefighter ratio, one that is far from the general population headcounts split of youthful able-bodied adults of approximately 50-50. At first one can conjecture that gender discrimination against women is at play. However, a very supportable Reality Ratio of 9 to 1 is right where it needs to be.

From the Sexuality Spectrum Headcounts Table above, the 40-5 general population headcounts split of heterosexual men to lesbian women is a ratio of 8 to 1. Then add in the bisexual men headcount of 5 who are likely mostly tops (think a few months in a NYC firefighter calendar), and the Reality Ratio of 9 to 1 is achieved from the 45-5 general population headcounts. One can contemplate how the primary Chasors want to be the firefighters to protect and save people, while the primary Chasees want to be protected and saved by the firefighter and then to potentially go on a date with them (it's the uniform!).

There are so many more examples to study including the high-ranking women law makers and law enforcement officers mentioned earlier who find themselves in the Mainstream Media spotlight, especially during the back-to-back to back 2020 seasonal crises. The verifiable sex partners of these women leaders will most likely show that a much higher percent of lesbian women are in these positions of power. By now one can surmise via the Sexuality Spectrum Science that this is not sexual orientation discrimination, but simply a reflection of the lesbian women's male hormonal drive towards achieving power and money—and at times notoriety—that comes with it.

Here are a few more closing concepts to bring up in terms of gender-based Equal Opportunities and income disparity considerations and how to explain the differences. The Sexuality Spectrum Science theorizes how if primary Chasee heterosexual women alone were to be compared to just primary Chasor heterosexual men on an Apples-to-Apples basis, the differences are not that far off. Then with Vanity Time per week factored in, the remaining gender pay gap

is explainable but alas still not leaving primary Chasee heterosexual women financially equitable.

This is where the concept of *Total Equality* then factors in what Chasees can earn via Indirect Pay subsidies just for their Company Time from Chasors in any given calendar year. Since it is as of yet an untracked amount, there is no telling how much in Indirect Pay subsidies via F-BET expenses, gifts, freebies, and favors are being transferred. At least for the sexually active youthful adult humans who are unmarried, the primary Chasee heterosexual women can easily be bringing in \$1,000 or more per month from their primary Chasor friends, including any who are lucky enough to have sex with them.

A second Sexuality Spectrum-related concept to be reinforced starts with reimagining the at times very misleading claims of women making less than men just because of their gender. As the studies continue, they need to document upfront all variables in their "all" women vs. "all" men results, and then provide a variable reconciliation.

Then add to this that while sexism might still be in play in some places and spaces of life in the USA's 2020s, it is really Chasor (i.e., heterosexual men *and* lesbian women plus some top-only gay men) vs. Chasee, and not simply penisagainst vagina-based. When the gender studies "experts" and others ignore the Sexuality Spectrum Science in discussing gender politics including employment discrimination, income inequality, *and* sexual harassment concerns, this is a blatant form of *Hormonal-ism*, hereafter making them *Hormonal-ists*.

Class Spectrum

There are and always will be a lot of factors that lead to one's current class status at a certain point of their lives. "Current" meaning in that calendar year; at that achieved age; at that point of education and training; and at that level of job experience. Yet unlike in centuries past and in other countries still to this day, current class status in the USA is no longer and is by no means a permanent position, no matter one's background or upbringing.

Never has there been a time where at one's fingertips, anything and everything can be discovered via the smart phone and other Internet connected devices, 24/7. A global reach that is unprecedented and practically unlimited in the super bandwidth age of the USA's 2020s. Basic hardware equipment and software packages in the modern-day form of the "app" have never been more affordable. Everyone now has the same ability to read the latest news, look things up, perform research, and most importantly, to self-teach given the mass availability of instructional and self-help videos, especially with sharpening

one's computer and tech skills. Anyone who cares to can take their destiny in their own hands.

Big Tech is there to provide every economic and social class the same exact and equal communications outreach. Never could people of any class status have thousands of consumer product options also at their fingertips and then at their door step the next day or two, for so relatively little cost. Email, text, facetime, video conferencing, and unlimited call minute and data plans are connecting people across the globe in the manner that only the Elite could do just a decade or two ago. This includes connecting with potential business and employment opportunities. None of the above sounds very *oppressive* compared to what it meant to be oppressed in centuries past.

With the Mind Spectrum one is often positioned compared to others based on the outside influences they have been exposed to historically and especially of late. As for the Sexuality Spectrum, one has no control over their position upon acceptance of how it is all nature and not nurture. However, one's Class Spectrum positioning at any given moment in their adult human lives is different. A lot different.

Upon entering adulthood, an abled-bodied human is in full control of where they will be in the years ahead. So much control that the Class Spectrum Science is a self-prophecy of sorts. If one values leisure time over income generation time, that is an individual choice. If one makes working hard their priority early on while maintaining some balance with their leisure time, the sky is not even the limit for individual financial success and prosperity in the USA.

The notions of trade-offs and risks vs. rewards loom large within the Class Spectrum, and so do positive energy, politeness, patience, and focus. That on top of never under appreciating the role of luck in terms of timing and being in the right place at the right time with the right people. In the same manner, the old school adage of "When there's a will, there's a way" should also be consciously embraced.

There will always be outliers with any spectrum. In terms of the Class Spectrum, there are certainly a small percent of people who are born into a permanent self-reliance class and never have to lift a finger to maintain it. However, no matter how one starts off in life; no matter who one is raised by; and no matter what childhood/teenager traumatic events one experiences or witnesses; the bottom line is that they still get the same exact 168 hours per week (24 hours per day times 7 days) every Monday morning at 6 AM. This goes for everyone

residing in the USA, completely independent of any individual physical traits or beliefs.

This important and inarguable fact then makes it easy to lay out the Class Spectrum's "168 Hours Foundation," which is comprised from the two very prominent trade-off characteristics of leisure time vs. income time. Leisure time spent socializing; with family; parenting, working for charitable causes; on chores; home repairing; on hobbies; playing sports; video gaming; sleeping; having sex; etc. Income time spent towards any legal form of gainful employment and/or self-employment, either of which can be on top of managing one's privately owned properties. Income time also naturally includes any schooling and training (even self-training) for future and/or higher income opportunities.

For those who are currently earning income, it is not uncommon to find some adult humans working only part-time, generally defined as 20 hours or less per week. Then in the USA's post-Affordable Care Act world circa 2010, full-time employment is now defined as 30 or more hours per week, putting regular full-time positions in the 30 to 40 hours per week range. At the same time, there are those adult humans who find themselves working 50 to 60 or more hours per week, which typically encompasses more demanding ways to earn a living.

To be clear, these work hours-related categories (i.e., up to 20; between 30 to 40; and between 50 to 60) are based on total hours spent working in the 168-hour week that everyone is equally allotted in the USA and is absolutely additive. Holding 2 or 3 part-time jobs at 20 hours per week places one in the 30 to 40 and 50-plus hours categories, respectively. The same is true for holding a 9 to 5 full-time job with 1 hour each day of break time but putting in a significant amount of overtime taking the 35-hour work week to something also in the 50-hours-plus range. Accordingly, herein lies the 168 Hours Foundation for defining the Class Spectrum's left, middle, and right.

Starting with the left, the characteristics combination of Leisure Heavy and Income Lite is labeled the "12-percenter." Working no more than 20 hours per week divided by 168 hours equals 11.9 percent and leaves plenty of time for leisure. This group includes the abled bodied adult humans who do not work at all. Next, the middle is represented by the standard "9 to 5 with breaks" work week, which averages 35 hours per week (7 hours per day x 5 days per week), allowing for a Balanced Leisure/Income lifestyle. The label "21-percenter" is then applied given how 35 hours divided by 168 hours equals 20.8 percent. Such average work weeks leave amble time for leisure activities.

There are then the abled-bodied adult humans who currently find themselves working way more than 30 to 40 hours per week. A work week that easily entails on average 50 to 60 hours or even more of their 168 hours. This type of effort translates into a major trade-off of leisure hours making them technically Leisure Lite and Income Heavy, the latter of which can be significant under an Equal Opportunities Capitalist society. This then derives the label for the category which sits on the right, i.e., the "33-percenter," by using an average of 55 hours per week divided by the same 168 hours which equals 32.7 percent.

A fourth multi-faceted category for adult humans is labeled the "N/A percenter." It starts with those whose self-reliance responsibility has ties to "dependent status" including marriage, divorce via alimony, and/or single-parent child support. Importantly, dependents exclude youthful abled-bodied adult humans who are not working/schooling/training while getting "the rent" paid by one's parent(s), via still living at home or other arrangement.

The N/A-percenter also includes those who are disabled, and can only survive with assistance from others, including the government. Then there are the retirees and elderly who with the available government social insurance programs plus life savings no longer need to work. In other words, the 168 Hours Foundation is *not applicable* to this diversified group from a self-reliance perspective. So, they fall off the main spectrum similarly to the N/A-sexuals, i.e., the Chaseless, who no longer engage in sex with other's aroused genitalia. The Class Spectrum now comes together as follows.

Class Spectrum Dependent/Disabled/Retiree N/A-PERCENTER <<< 168 Hours Foundation >>> Leisure Heavy / Income Lite Balanced Leisure / Income 12-PERCENTER 21-PERCENTER 33-PERCENTER

To help with remembering the Class Spectrum's categorial labeling, one can use this simple Math trick. Think 12-percenter first; reverse 12 to get to 21-percenter; then add 12 plus 21 to get to 33-percenter. This trick is also a stark reminder of how the 33-percenter works as much and as hard as the left and

middle combined. Further, those adult humans living week-by-week with all leisure and zero income time fall on the spectrum's end point on the left, or perhaps better said, dead end. Even though the 0-percenter is not explicitly shown, they are implicitly recognized as a critical subcategory of the 12-percenter. At least in the sense of what exactly their fair share offering is to Society as a whole.

Nonetheless, the underlying premise of the Class Spectrum Science is that one's work ethic week after week and year after year is the key to transcending one's current class status. A work ethic that employs regularly making sound individual choices; realigning priorities as necessary; and recognizing how life is one never-ending series of trade-offs. It also includes one's individual responsibility to get things done, and when they do not get done or are done incorrectly, holding oneself accountable versus passing the blame along to others.

This is all straight math in figuring out life's equation for success and prosperity under a free and fair Equal Opportunities Capitalist society. It basically comes down to how productive and honest one will be with their next allotted 168 hours starting at 6 AM on Monday morning and taking things forward from there. Thinking in terms of an individual "PH level" and using a self-determined hypothetical scale of 0 to 10, one can internally gauge just how productive and honest they will be with those next 168 hours. The efforts put forth to build and maintain one's individual self-reliance and self-well-being.

As for building and maintaining self-reliance, setting achievable income generation goals in multi-year or just multi-month segments and then working hard towards those goals is key. As for taking one's self-well-being into one's own hands, the key is overcoming bad habits while creating better habits towards maintaining health, especially with one's own weight and immune system.

There are plenty of available means to self-learn and self-fitness in today's USA. At the same time, one can evolve their drive to do better by perfecting how to double and even triple task when concentrated and focused. Earlier generations most certainly overcame greater hardships than youthful adult humans in the USA face today. Especially given how there are plenty of affordable opportunities to attend higher education while still earning income.

It is a best practice to look at 100 percent "pure" leisure time for any given week or weeks as something that is individually earned and not entitled. Earned though working hard enough and saving enough to take multi-week vacations if self-employed or to accumulate increasing employer-based allotments of paid time off. The same goes for no longer having to work at all

and still covering all of one's monthly bills. Unfortunately, the combination of the USA's federal, state, and local government entitlements are now creating 100 percent pure leisure time that is more valuable than work as will be emphasized shortly.

In the Class Spectrum's middle, the 21-percenter typically lives a life which pays the bills and affords them ample hours per week for having fun, raising children, or both. Hobbies and child-related events whose participation hours are right after their normal 5 or 6 PM quit-time jobs are rarely missed, and almost never interrupted or interfered with on the weekends. It also affords those who are schooling at night more time to hopefully excel their income in the future, beyond their current class status.

For the 12-percenter on the Class Spectrum's left, missing events or canceling a family outing is rarely an issue. On the other hand, keeping up with one's monthly bills, especially the rent or one's mortgage, not so much. As a secondary income earner in a household, the extra cash can be a blessing. But if one is abled bodied and living life single, part-time employment is a dicey path towards prosperity in an Equal Opportunities Capitalist society. Unless attending school at the same time or easing oneself into full retirement after working full-time for the decades prior. This includes minimum wage positions which were never meant to be a lifetime wage in any society.

Sitting on the Class Spectrum's right, the 33-percenter label covers a very diversified group of small businesses, trades, and professions. These start with the owners of the local deli, dry cleaners, hardware and convenience stores, beauty salon, bar/restaurant, and many other types of small businesses. All of whom need to make payroll every pay cycle and cover all operating expenses before taking a cut for themselves. In this same bucket, there are also many 33-percenters found amongst the employees who support these small business owners. For example, this can be regularly found in the bar/restaurant industry where working 10 to 12-hour manager/bartender/server shifts 6 or even 7 days per week can be the norm. That is, 10 to 12 hours per shift just serving customers, and not counting the hour or so spent opening up for daytime shifts or closing after a nighttime shift.

The many physical and skill-oriented trades also claim a high portion of the 33-percenters in the USA, consisting mostly of the aforementioned Chasors and often unionized-driven trades across both the private and public sector. Plumbers, electricians, sanitation engineers, police, firefighters, truckers, and on and on are all known for working long days, overtime, overnight, and/or on

weekends. With such overtime demands, many easily can exceed 60 hours or more per week for months at a time.

The 33-percenter category moves on from there to those who have chosen the many high-intensity professions in which the formal education required and the ongoing maintenance of one's Continuing Professional Education (CPE) credits is just a fraction of the job's demands. These include accountants, actuaries, doctors, investment bankers, nurses, and lawyers. Being on call, working weekends, 12-hour workdays, and even having to work while on vacation, are just par for the course.

The need for the explicit 0-percenter sub-category within the 12-percenters now becomes painfully obvious given how lopsided their leisure time is over all others who work at least part-time. It is just not the work hours that are saved. No commuting. No out-of-town traveling. No job-related deadlines or pressures. No juggling. No start or end times to make or miss. No coordination demands. For most, personal monthly bills if any, are afforded via non-contributory government entitlement programs or by others especially via sexual partnerships. For many, this is a chosen lifestyle class status vs. a normally 21- or 33-percenter who is between jobs with or without severance or dealing with another prolonged virus outbreak-related government shutdown period.

The 0-percenters also include all the abled-bodied adult humans who manage utilizing varying proportions of their 168 hours towards illegal and/or destructive activities, whether for income or not. This does not include those who at the moment are working legitimate jobs but are not reporting all of their income for whatever reason. They are at least building a bridge towards self-reliance without causing any physical harm and/or destruction to others.

In the USA's 2020s, there is quite a growing number of abled-bodied and especially youthful adults who protest, riot, loot, vandalize, trespass, and/or occupy as their only job and income source. Whether it's paid in cash by the community organizers who are fronting the behind-the-scenes powers that be, or simply takes the form of stolen goods proceeds, it is not moving them—in any way, shape, or form—towards a self-reliance as well as self-well-being class status.

In fact, the complete opposite is true in terms of preparing one for a future self-reliance and self-well-being life via legal means. First, there is the obvious fact that the acts of protesting in confrontational ways such as blocking traffic, breaking curfews, and/or yelling in the face of those dining at a restaurant can

lead one to a first arrest. For many, it just adds on to their arrest record. Then there is the extreme end of modern-day protesting to complicate matters even further.

That is, one's complete detachment from the immoral and irrational claim that "they have insurance" so it is okay to loot and burn down their business, or simply condone from afar while videoing it all. No one who thinks or says that will ever run a business given how they are so obviously incapable of comprehending how much effort it takes to build one. The amount of one's personal financial investment, the risks taken, and the 1,000's of invested hours which no insurance claim can ever reimburse.

To the extent there are small business insurance policies in place, it is also shameful and incoherent to assume it would cover losses due to civil unrest. Even if they did, the immediate loss of income adjustments; the time investment demands of filing a claim; and the coordinated decisions necessary for replacing inventory and repairing/rebuilding physical buildings are *not*. All of that plus the uncertainties created in rehiring employees, retaining regular customers, and just how much one's insurance premiums will rise, assuming there is still an insurer willing to continue the policy at all.

Alas, this sets up a more focused discussion on all of the present-day Equal Outcome concerns. Concerns which always seem to only focus on gross incomes earned in just one 12-month period. When tax policy is brought into the discussion, it is always about making the high earners pay their fair share. There is complete silence on how they already *are* paying their fair share especially compared to those who do not work or only work part-time. The conversation never focuses in on what the net "Outcome Ratio" is, just the top marginal tax rate percentage. Unless of course tax cuts are under consideration, and then suddenly, the focus turns to how much the high-earners will be saving dollars-wise over the low-earners.

The Class Spectrum Science takes care of putting everything in perspective by considering 1) Individual Income; 2) Government Intervention via income and payroll taxes vs. government cash and cash-in-kind transfers; and 3) Net Outcome. The Science zeros in on the resulting Outcome Ratio between the 33-percenter, 21-percenter, 12-percenter, and especially the 0-percenter. The following Income-Outcome Table speaks for itself for the four categories, assuming all are youthful or mid-life abled-bodied adult humans residing in the City of New York. One just needs to focus on the green vs. red shaded ratios to

feel the reality of the already in place Outcome Ratios in many Progressive Socialist run cities:

As the above hypothetical Income Ratios portray, there is a big difference between the various Class Spectrum categories of up to 33.33 times, as highlighted in green. However, when one factors in what the collective governments are already subtracting or adding for those residents in New York City, the Outcome Ratios are extremely crunched. So much so, that the dollar outcomes are basically equal at \$5,000 per month (\$60,000 per year) between the 21-percenter, 12-percenter, and 0-percenter. An Equal Outcomes result for sure. With a Net Outcome value now greater than zero, an Outcome Ratio between the 33-percenter and the 0-percenter can be measured at 4 to 1 as highlighted in red.

The 4 to 1 Outcome Ratio is a remarkable feat for the 33-percenter vs. 0-percenter comparison given how much it takes for one to earn \$400,000 in one calendar year. Yes, despite the significant Leisure-time Lopsided-ness inherent between working on average 50 to 60 hours per week vs. not working at all, the 0-percenter ends up that close to the hard-working 33-percenter. One has to wonder how "living below the poverty line" as a 0- or 12-percenter in NYC is not so poverty-like after all, at least after factoring in the Leisure-time Lopsided-ness.

As a reminder, those who report their full incomes in a given calendar year are on the hook for paying every cent of what they owe in taxes or will face fines

or even jail time. If they cannot come up with the money by the following April 15th, they then will accrue interest on top of what's owed as well. In comparison, those who report little to no income—not to mention keeping "under the table" anything earned through illegal means—and qualifying for entitlements de jour along with zero responsibilities. The total of what they receive year after year in government assistance is individually tracked nowhere, reported nowhere, and rarely is taxable. They do not face any interest payments, nor jail time, and never have to pay back any of it, even when they happen to hit it big financially in the future. Call it what it is - *12-percenter privilege*.

This is a good point in the Class Spectrum Science discussion to focus in on the individuals who leverage off their marketable talent for playing professional sports, entertaining, acting, writing a book, etc. The USA's ever evolving progressive tax system is telling them that they cannot keep even half of the millions legally earned in just one 12-month period. It is basically a slap in the face that one better not get too used to living too much of a higher-end lifestyle. One that could have been easily maintained for years to come if one were allowed to keep two-thirds or at least half of what they earned. The reality is that not many individuals can repeatedly monetize a talent beyond a few tax years, especially when it comes to professional sports.

The government is certainly okay with making it seem like one is set for life after making \$10 or \$20 million per year, for x-number of years in a row while still youthful and abled-bodied. But do not dare establish a lifestyle with monthly bills that one can afford now but no longer once the gravy train runs dry. That is because the government has already had its "fair share" to redistribute—while taking their administrative cut—often leaving one in an insurmountable hole for continuing their attained lifestyle post-marketable talent period.

Even without any marketable talents other than a hard work ethic, some will figure out a way—usually after many years if not decades—to start earning over \$1 million dollars in multiple 12-month periods. Meanwhile, the abusively named "millionaire's tax" really makes no sense when one thinks about it. Always in the form of once again increasing the top marginal rate and/or introducing additional top-tier income tax brackets, it literally does not add up. Especially in New York State, where once a taxpayer hits that \$1 million, the top marginal rate is then applied to every dollar earned before \$1 million.

On top of the state's take, next factor in the chunk that the Federal government grabs at that level and the \$1 million is down to \$500,000 or less

right off the bat. Subtract regular attained month-to-month living expenses, say \$10,000 per month, and now that earner is down to having just \$380,000 left over (\$500,000 minus, \$10,000 times 12 months, equals \$380,000). "Millionaire's tax" is just a stupid but empathetic-sounding name for another income redistribution scheme. The much more appropriate name going forward is "Can't become a millionaire in this state tax."

On the opposite end, the aptly named "Zero Motivations Pass" must be contemplated. How many of the 0-percenters have zero motivation and as a result no intentions of giving up their leisure time along with the thousands of dollars they receive in government entitlement transfers every month. Entitlements with no restrictions on leisure time activities and no productivity or even honesty requirements to keep the entitlements coming week-afterweek and year-after-year.

The Zero Motivations Pass can also play a role with the 12- and 21-percenters, when such an individual claims that they cannot afford, say their own childcare expenses on items such as diapers. Upon such an encounter, one must take a step back within the Class Spectrum Science. Is it a monthly expense item they truly cannot afford, or that they choose not to afford? As they politically support and then embrace the ever-increasing child earned income credit, they somehow still manage to afford the latest fashions and/or tech gear without hesitations, plus make it out with their adult friends multiple times each month.

A second important Class Spectrum-related point to absorb is the concept of "Absolute Outcomes," and how it proves that the USA's 2020s is much closer to Equal Outcomes then meets the naked eye, despite its Equal Opportunities Capitalist society underpinnings. Part 1 is accepting the Income-Outcome Table ratios displayed above and recognizing how it encompasses at least 98 percent of those currently residing in the USA. That is, there are roughly only 2 percent or less with annual household incomes above the \$400 thousand level, with many if not most living in the USA's progressively taxed cities. As a result, most residents will fall within just a 4 to 1 Outcome Ratio, which sounds very reasonable.

Part 2 is acknowledging how Leisure-time Lopsided-ness once and for all needs to be factored in by assigning a dollar value to each extra hour. Each extra hour on average that the hard working forgo while the non-working have them all. Borrowing from the Mind Blind's never-ending "Fight for Fifteen"

campaign's minimum wage battle, each hour of extra leisure time between the Class Spectrum categories can be multiplied by \$15.

For example, the extra leisure hours difference between a 0-percenter and a 33-percenter is easily 50 hours per week. 50 hours times \$15 per hour equals \$750 per week, or over \$3,000 per month. Quite an Absolute Outcome, indeed. Adding \$36,000 (\$3,000 per month times 12 months) makes that 0-percenter a \$96,000 Absolute Outcome resident (\$60,000 in non-taxable government transfers from the Incomes-Outcomes Table plus the \$36,000) while residing comfortably in the USA.

Clearly, the Income Inequality vs. Leisure-time Lopsided-ness battle is finally worth having and truthfully addressing. The well-deserved Front-end Why's will be finally on display. The current USA, with its rather progressive tax rates, both at the federal and on many state and local levels, is already delivering on flattening outcomes. Yet for the Mind Blind, the only acceptable answer is for everyone to be paid equally no matter the job or profession, or to simply be paid by the government for not working at all via some form of universal basic income scheme. All while trying to do away with basing raises on individual performance, productivity, efficiency, and especially merit. In plain English, this is nuts.

The annual income of the high earners must always be compared on a net outcome basis, especially when presenting any arguments that taxes need to be raised. Then, for everyone else who is abled-minded and bodied all forms of government transfers need to be factored in, which will admittedly not be an easy task. That is given how many income redistributive programs there are such as welfare payments, food stamps, Medicaid, rent and utilities subsidies, cell phones, Internet, etc. The misleading claims against Income Inequality could be turned onto their misconceived head by pointing out the Net Outcome *Equality* that the USA already delivers on.

Lastly, a moral society must ask itself when so much is promised as free is not there a need to spell out the why this is fair, or more accurately, inherently unfair? It completely ignores the obvious Trade-offs. It completely ignores how some want to keep their achieved self-supporting lifestyle going in retirement by saving on their own. It completely ignores how some would rather just smoke weed everyday while living vs. work for a living. Those who push for even more income redistribution are clearly *Trade-off-ists*, who are guilty of regularly exuding their *Trade-off-ism*.

Fast Forward

The beauty of the new Spectrum Science is that it empowers adult humans to self-measure themselves—especially the latest generations—in terms of where they stand amongst their peers. Each spectrum makes it all black and white for any who care to see and self-internalize on what truly makes their collective character foundation in a modern-day tech-driven world. A character foundation that is independent of all physical attributes and any cultural beliefs.

The components behind Spectrum Science are very straight forward. It starts with a clear and self-identifiable foundation and it's two most prominent characteristics. The two characteristics are then used to create four categories which make up the spectrum's left, middle, and right, along with a connector. This is conveniently captured in the following Spectrum Science Summary Table:

It is important to note that there is no specific correlation between the spectrums. An adult human can find themselves in the middle on the Mind Spectrum; on the left on the Sexuality Spectrum; and on the right of the Class Spectrum. Or any other combination. Notably, it always happens that the left side of each spectrum calls for the most attention. This is basically due to how many more moving parts and complexities that the Mind Blind, the Chasee, and the 12-percenter humans hold over their respective spectrum counterparts.

Drilling straight down on the far left, the 0-percenter subset of the 12-percenters calls for a lot of ground to cover. USA 2020 entitlements long ago stopped looking to raise the class status of the unemployed abled-bodied adult human by working with them directly. The government goes so far as to give preferential treatment via "investing in the community" with little to no assigned individual responsibilities or accountability. Such investments are the opposite of cultivating self-sufficiency, i.e., raising one's chances of creating and

maintaining self-reliance and self-well-being. Combined USA Government entitlements for abled-bodied adult humans have now officially transformed from being a temporary bridge to a permanent lifestyle buoy.

In the complete opposite direction, there are the Chasees who have come a long way circa 2020 within the USA's Equal Opportunities Capitalist society. They are earning as much or more than their Chasor counterparts, but still hold the power of the first-night sex partner final decision. It is also worth noting how—despite making a lot of money on their own—Chasees are still not paying much for Chasors in any real consistent way, except perhaps once cohabitating with one's sex partner. As an aside, one thing to keep an eye on is how soon robots will replace the physical labor occupations dominated by the Chasors, rendering them obsolete—except perhaps for sex—in the eyes of the Chasees.

However, the Mind Blind have the most moving parts and complexity, especially given the USA 2020's magnitude of annual incomes potential and obtained wealth over any other country in history. It is not easy to keep track of how much free stuff one can and is promising as a Mind Blind politician or at least power corrupted one. The victim-villain strategy to gaining and holding power does not come easy as well. In fact, it is necessary to constantly evolve one's position year after year, or even from one week to the next. For example, the Mind Blind have had to switch their identity ideology from mostly class and gender politics to race and sexuality politics in what seems like just a few years.

Then there are the almost weekly evolving meanings of words and/or concepts such as peaceful, violence, vandalism, self-defense, and criminal. Picking and choosing where to point out diversity needs (corporate boardrooms; NHL; etc.) vs. those to avoid (government jobs; NBA; etc.) is also a lot of work. Even more demanding is keeping on top of who or especially what American—or even global—traditions need to be cancelled next. Canceling individuals for what they did, said, or just thought is one thing. Attempting to cancel decades or even centuries-old traditions such as the 4th of July, Christmas, or the Nobel Peace Prize takes the cancel culture to an entirely different level.

As should be obvious by now, one must jump through hoops to fundamentally change the way a country's residents live to effect foundational, systemic, and structural change. Better said, to truly deliver on that of late forsaken promised hope and change. Especially important are the means and control to regularly substitute indoctrination for education at every turn and human interaction. Income and wealth redistribution are just scratching the surface.

Nonetheless, the beauty of Spectrum Science is that human race and ethnicity is irrelevant. While each ethnicity might be distributed differently in each Spectrum's respective four categories, a group of adult humans of any one ethnicity will be spread amongst *all* of them. In fact, the way the USA is evolving, mixed ethnicity adult humans will make race and ethnicity even less significant as it should be. These two facts alone should help nail down how the Mind Brands are now officially *the* cultural phenomenon which transcends race, ethnicity, gender, sexuality, and current class status. Certainly, no other cultural denomination can compare any longer.

The EO Twins Finite and Future just happen to now re-enter the picture. News of the pending breakup of the USA has both ultimately overly excited and hopeful, but with certain completely opposite reservations. Instantly, the new Spectrum Science grabs Future's intrigue and then some. However, Finite is not as enthusiastic at first, and challenges whether it is some Fox News talking point, and simply needs to be dismissed as sexist and racist sight unseen. Especially the concept on how many hours there are in the week and that everyone equally gets 168. Besides, between Project 1619 and Critical Race Theory (CRT), as well as various media institutions like the New York Times and CNN, Finite already understood the way's, what's, and the "Back-end Why's" the USA has always been and still to this day an unfair place to live in every way imaginable.

Quite the opposite reaction, Future, upon first seeing the Spectrum Science Summary Table discussed on Fox News, cannot wait to learn more. The leading-edge concept of human behaviors *not being random* and the discovery of the "Front-end Why's" really appear to be self-empowering enough to simply use one own eyes and ears to own it and live it, as advertised. Through other resources via the Internet, Future decides to self-research and self-learn how the three spectrums are similar and where they differ.

Always the more ambitious twin, Future takes the time to create a side-byside table of some of the specific nuances between the spectrums. Each of the three spectrums were overlapping in terms of a prominent Indifference Trait, an Override Feature, and a newly identified Discrimination Form summarized as follows:

The Indifference Traits all seem to give the leg up to each Spectrum's left end as follows. The Full Intolerance Shield appears to always protect the Mind Blind from any accusations of wrongdoing or creating any trouble. Meanwhile, the No Intentions Badge affords the Chasee the chance to keep their options open via the ability to pick and choose who they have first-time sex with at practically no cost, even in a nearly Gender Equal Pay world. Even more interesting, the Zero Motivations Pass appears to provide any type of 0-percenter—non-criminal or otherwise—the ability to live comfortably without any kind of real responsibilities or restrictions.

Meanwhile, the respective spectrum Override Features appear to put things in a better perspective once accepted by considering the bigger picture. The Power Corrupted amongst the USA's 2020s politicians across party lines are probably more prevalent and at the same time, more identifiable than ever before imagined. The acceptance of Total Equality as a key measurement of financial equity between the genders makes more sense than ever in a society where marriage and raising a family—or even just cohabiting—are secondary concerns for many. In the same manner, when discussing class status metrics, the Absolute Outcomes stipulation makes it abundantly clear that a successful Capitalist Equal Opportunities society already takes care of its own despite the rhetoric saying otherwise.

Lastly, when it comes to the newfound and specific Discrimination Forms across the spectrums, all make sense on how ongoing ignorance of the Spectrum Science could really impede any Capitalist Equal Opportunities-driven society. On the other hand, regularly practicing them—admittedly or not—can internally give unflappable cause and justifications for tearing it all down in favor of a Progressive Socialist Equal Outcomes-driven society. The stark reality is that varying forms of Brand-ism, Hormonal-ism, and Trade-off-ism have been brewing and festering throughout the USA for decades, which will undoubtedly be a better place with much less of all three.

Future found that the biggest differences vs. the above similarities were just as important to understanding the Spectrum Science and his own *thought process foundation*. How one's Sexuality Spectrum position was controlled by one's specific hormonal mix at birth making it even easier to formerly acknowledge individual sexual preferences no matter one's personal and religious beliefs. Then with the Class Spectrum, it was obviously straight forward how the tradeoff between one's leisure time hours and income generation hours really will drive one's own prosperity prospects. However, it was the Mind Spectrum that

one could also individually control *but* needed to be weary on the stronger than ever influential forces, especially in the education, media, and entertainment sectors of the USA's 2020s.

Upon Finite and Future finding themselves in the same room together (amongst others thankfully), Future tries to reason with Finite on how the Spectrum Science can be the final answer on why the USA should be broken up into two countries. Rumors at that time were that the Mind Blind could take the west coast and Hawaii under the name Utopia Socialist State of America (USSA). The Mind Balanced could then retain the remaining 46 states and lead the scaled-down-in-territory but enhanced in freedom and spirit USA forward.

It is at that very moment when Finite starts paying more attention to Future. Is this possible? A chance to prove that Progressive Socialism works when done right with the right leadership? It sounded too good to be true, but here it was at the doorstep in Finite's early-on lifetime. To the extent working hard, can do attitudes, saving for the future, embracing math, or even just scheduling, is not what one is into, the USSA will be the perfect place to live. It will do away with such inherent racism as diligently and *honestly* documented by the 1619 Project and CRT, instantaneously.

But then Finite starts to wonder and worry out loud. Future did have some interesting points about how an Equal Outcomes culture would function in the USSA on several fronts. How many high-earner taxpayers will be needed for providing the necessary and year after year after year income transfers for all of the government entitlement recipients, and will they continue to work hard enough while surrendering more than 50 cents on every dollar earned, especially later in the calendar year?

In the same way, what about how a society cannot have tenants without private landlords who have and take all the responsibilities, unless of course if the government becomes the landlord for everyone. Even more concerning to Finite was how will unions fare when private business owners and Corporations do not see the sense of taking the risks of success or failure once profits take a permanent back seat? Will the USSA's carefully crafted vision of all-inclusive workers' rights over management be setting itself up for failure?

Future has this to say in response. One can have plenty of high-earner taxpayers without any government entitlement recipients. Obviously, it does not work the other way around. One can have private property owners without tenants, but tenants cannot have housing without private property ownership other than through the government. Likewise, one can have private corporations without unions, but one cannot have unions without private corporations. Please let that sink in.

Future then asks Finite, won't the USSA have a need for some common middle ground between the makers and the takers? This then opens the door, albeit only momentarily, for Future to contemplate even more questions directed at Finite. In any fight for "equality," how does one know when the war has been won? What are the metrics for it? Technology to gather metrics is everywhere, which means that there is no longer a real reason not to have measurable outcomes in play. What will the "soldiers" who served in the fight for the Equal Outcomes do with their time and how will they earn a living once the war is presumably won? Or does one just not keep score? Or just moves the goal posts? Or just imagines more inequitable issues to focus on for the existing victim groups and/or devises some new victim groups?

Also, why is Capitalism only measured as fair or unfair by gross income disparities in a single year and absolutely nothing else? What about all the conveniences that every class status level now has? How many luxury-like items do they personally own, just to take them for granted? How many personal services do they regularly have access to, especially beauty salon, spa, piercing, and tattoo services? How often do they have the pleasure of shopping for hours—in person or online—at a time? Are those counted as "living under the poverty-line" in the USA really that or just not reporting all of their income, especially the year-round paid protesters?

At this point, it should be no surprise that Finite stopped feeling comfortable at least three paragraphs ago and as a result both Finite and Future mutually decide to part ways for the night. However, not knowingly, this would end up being the last time that they would ever physically stand in the same room together in their lifetimes. Finite will follow a self-willed internal calling to move to the west coast the very next month to help lead the way for the new USSA in whatever capacity the Mind Blind leaders need. Meanwhile, Future will find destiny in emerging as one of the many independent thought leaders in the USA. A thought leader who will help reinforce and assure that an ever-freer lifestyle and path towards achieving the American Dream in the USA is permanently here to stay.

It is now more than ever time to clear the path for the likes of the EO Twins Finite and Future as well as others similarly ideologically opposed. To clear the path for them to go their separate ways in the new USSA and the reinvigorated USA, respectively. The path will also be cleared for those who find themselves aligning with the reigning powers that be, aka the Mind Blind vs. the Mind Balanced, even if for a lack of a better choice.

The Mind Blasted will stay or go depending on the various radical subgroups they fall into. Certain Mind Blasted subgroup radicalness aligns better with the Mind Blind, especially in terms of wanting to control other adult human lives. Then again, other Mind Blasted radical subgroup thinking is completely against what the Mind Blind desire, and thus they will likely default to staying in the USA. In the same manner, kind of, the Mind Blown will be naturally drawn to migrate as soon as possible to the west coast and continue to act as loyal and "pure pawns" of the Mind Blind in the new USSA.

It is officially safe to say that it is not working out for the Mind Blind and Mind Balanced getting along longer term. Very predictably, the Mind Blind have become more vocal and visible with their disdain for everything that represents America. It was to be expected once their visionary dreams for an Equal Outcomes Progressive Socialist society and "demographically-driven" power reign became threaten. All it took was one outsider non-power corrupted Mind Balanced leader with a little less empathy to Just Say No More to the Mind Blind's endless push to the left. One who came about not just to curtail but to punch back ferociously as necessary.

Up until that moment, the Mind Balanced had constantly and consistently conceded at every turn. The problem has always been that the Mind Blind have not been willing to concede a single inch. Upon just one Mind Blind outspoken leader conveying a new progressive idea, all Mind Blind religiously embrace it without hesitation and then never ever let it go. All or nothing is a dangerous game, especially when it is only one side that agrees to it. Reasonable people who are forced into unreasonable acts can only be stretched so far. When they snap, they likely will no longer appease, accommodate, or retreat, which is when the real problems start. The USA's 2020s have witnessed this digression early on.

All of it has the makings of a civil war, one which has started on the ground and is already accumulating causalities both physically and property-wise. The Mind Blind propaganda narratives centered on the COVID-19 pandemic shutdowns and racial injustice protests are the first shot. The bottom line is that the Mind Blind have always had the *rage* ready to go vs. the Mind Balanced who can take what seems like forever to say enough is enough. Upon the Mind Balanced doing so, the Mind Blind can quickly go from basic levels of rage and little common sense to complete *outrage* and zero common sense. That is compared to under normal times when the Mind Balanced—who are traditionally non-confrontational—follow their instincts with individual critical thinking and common sense in how best to respond to the threat.

The good news is that the split into two separate countries will solve for all of the above. Of course, it will not be all fun for the ongoing USA. That is, hard work; improving lives on the ground; encouraging people to get off welfare and get jobs; to start businesses; to have children with a father that sticks around; to stay away from drug addiction; and to avoid gangs. Reinforcing the fact that government mainly exists to provide domestic tranquility (security) and provide for the common defense on top of basic collective government services, none of which are meant to guarantee Equal Outcomes at any taxpayers' costs. It really is that basic.

Another not fun but basic and necessary exercise will be keeping track of any remaining Mind Blind residents and where they are fleeing to upon the breakup. There will be no need for them to do any more damage to the historically Mind Balanced-lead USA by clinging to their same exact Victim-Villain philosophy and Equal Outcomes burning desires.

On the other hand, the USSA will deliver just the opposite for those who cannot be bothered. The concept of working hard will be out the window in favor of entitlements, and the Free Stuff Fair Share mandate that is immediately adopted. The USSA will be a place where one can leisure all they want. It is pretty much a hard-cold fact that an Equal Outcomes Progressive Socialist society will *always* work for those who do not or will not. A Utopian society where everything from eliminating the unjust Electoral College to making sure every school participant gets an A; every sport participant gets a trophy; and even every movie gets nominated for a best picture Oscar. And of course, college is free and all student debt up to that point is canceled overnight.

This will be a dawning new era like no other in terms of intense virtue signaling, while competing in the display of one's progressiveness in practically every public forum, especially on social media. Conformity of thought will be paramount second only to displaying the right opinions, again and again to one's captive audience. Diversity quotas will be the rule for everything, no matter if it de-legitimizes the award. The notion of "caring" will insist on taking the side of social and racial justice while dismissing the safety concerns of one's neighbors and property, all while keeping any discussion on crime—in any light—as suspect at the minimum.

New rules and regulations including for any pandemics will never be questioned and at the minimum will give the illusion that there is a method to the government's self-interested judgement madness. The Progressive Socialists will no longer have to pretend to support policies that appeal to the nation and can finally stop hiding their true intentions of eliminating the USA's original Constitution and Bill of Rights outright. A big relief indeed.

The proportion of takers to makers, at first, will be a big deal in the USSA. So, will increasing existing and inventing new government revenue sources. But the Mind Blind, as they always have claimed, will lead the way to this new form of spiritual prosperity. A prosperity wherein everyone can wake up every day knowing that everything and everyone will be living under a truly Equal Outcomes order. Economic and social and racial and environmental Justice for all.

For those who remain in the USA they will only be able to observe from afar. The Mind Blind in all their glory within the new USSA will be a sight not to be missed. Especially in the soon to be most sort after place to live in in the USSA, the City of San Francisco. A city which has for years been one of the most Equal Outcomes-oriented and way ahead of its game in perfecting *the* model for Progressive Socialism.

The USSA will rely on one centralized and unarmed public peace force, while at the same time all "weapons of war" will be banned *only* for law-abiding and hard-working taxpayer residents, especially small business owners. Other Justice initiatives will include the legalization of resisting arrest *inclusive* of going on the offensive against said unarmed public peace officers, as warranted.

Other Justice initiatives already in practice on the west coast will include an expansion of the "sanctuary state for shoplifting" rules, especially for any residents who simply at the moment need the cash to buy a loaf of bread. In the *USSA or Bust* section of Chapter 2, even more positives of the breakup will be covered including the inevitable addition of the "P" for pedophile to LGBTQ. Then there will be a layout of *Rights Reimagined*, inclusive of both human and anti-human rights. The *Grievance Economy* section is where considerations are contemplated on how the USSA will finance it all while keeping the "free" in free stuff and the "fair" in fair share. Lastly, the closing section, *Cascading Causes*, will address potential conflicts of identity groups and keeping one's narrative straight on who are the obvious and latest oppressed victims vs. the oppressor villains.
